

The Forest Legacy Program protects important forest lands by purchasing conservation easements or fee titles from willing landowners whose lands are threatened with conversion to nonforest uses. Forest Legacy properties offer recreational opportunities, watershed protection, timber resources, wildlife habitat, and protection from development.

Forest Legacy Program Synopsis

Program Purpose

The purpose of the Forest Legacy Program (FLP) is to protect environmentally important forest areas that are threatened by conversion to nonforest uses.

Program Description

The Forest Legacy Program is a partnership between participating States and the Forest Service, U.S. Department of Agriculture. These entities work together to identify important forest lands and protect them for future generations.

Conservation easements are the primary tool used to achieve this goal. Priority is given to lands that have important scenic or recreational values; riparian areas; fish and wildlife values, including threatened and endangered species; or other ecological values.

Program Characteristics

- The Forest Legacy Program is entirely voluntary. It operates only in States that have elected to join the program.
- The program helps States and regions identify important forest areas. Lands targeted for protection must fall within designated Forest Legacy Areas.
- State and local partners select priority tracts in cooperation with the Forest Service.
- The program is based on a “willing seller and willing buyer” concept.

- When conservation easements are used, the land remains privately owned.
- Other protection tools include full-fee purchase, voluntary deed restrictions, covenants, and agreements.
- The interests in land may be held by the Federal government or by the State or a unit of local government if the State chooses to select the State Grant Option as authorized by the 1996 Farm Bill.
- When the Federal government holds the easement, State or local units of government agree to administer the lands or interests in lands.
- The lands and interests are held in perpetuity. In the case of interests in land, there is no loss of the Federal investment resulting from change of ownership.
- Forest Stewardship Plans that meet the landowner’s objectives for natural resource management are prepared on all privately owned tracts.
- The tracts acquired can remain “working forests” and can forever provide forest resources to meet the needs of the local community and the Nation.

Forest Legacy Program of Northeastern Area State and Private Forestry


This report outlines program activity and accomplishments in the 20 States served by Northeastern Area State and Private Forestry (NA S&PF), a unit of the Forest Service, in Fiscal Year (FY) 2010 (October 1, 2009–September 30, 2010).

- All 20 States served by NA S&PF have voluntarily joined the Forest Legacy Program.
- In FY 2010, accomplishments occurred in 11 of the States served by NA S&PF, where a total of 104,887 acres was protected from conversion to nonforest uses. NA S&PF's cumulative FLP accomplishments since 1993

total 1,419,165 acres on 372 tracts through September 30, 2010. The total Federal FLP investment of \$226,805,000 in the States served by NA S&PF has protected forests valued at \$478,835,000 through conservation easements and fee acquisitions since 1993.

Partner Roles

The Federal Role

The significance of the public benefits of a particular forest ranges from local to national in scope. Larger forests tend to be nationally significant because as forest size decreases, the values they provide diminish. Extensive forest areas are often subject to the additional challenge of multiple ownerships and numerous political jurisdictions. Through the FLP, the Federal government helps State and local governments look beyond their political boundaries to identify important forest areas. The Federal government provides oversight, and financial and technical assistance to help protect important forests.

The State Role

States integrate partner resources to cooperatively protect and maintain a forest land base. The lead agency, usually the State forestry agency, carries out the FLP in the State. Responsibilities include the following:

- Collecting information to identify and delineate important forest areas that may be selected as Forest Legacy Areas.
- Consulting with the State Forest Stewardship Coordinating Committee to achieve program purposes.
- Addressing land protection and forest management issues.
- Conducting land acquisition activities.
- Integrating policies and incentives to conserve a forest land base.
- Holding and administering the lands or interests in land that enter the FLP.
- Monitoring tracts for program compliance.

The State Forest Stewardship Coordinating Committee Role

The State Forest Stewardship Coordinating Committee's role is identified in the Cooperative Forestry Assistance Act. The committee acts as a consultant and makes recommendations. Its duties for the FLP, identified in the act and FLP guidelines, include:

- Establishing eligibility criteria and recommending Forest Legacy Areas in the Assessment of Need process.
- Prioritizing lands for inclusion in the FLP.

- Advising the State lead agency to achieve FLP objectives.

The Nongovernmental Organization (Land Trust) Role

Nongovernmental organizations, specifically land trusts or similar organizations, have a distinct relationship with the FLP. Because of their compatible interest in protecting land for conservation purposes, land trusts can be a primary contact with landowners to negotiate the purchase of conservation easements and to monitor the conservation easements once they are enrolled in the FLP. Lands acquired by or donated to land trusts may be counted toward the non-Federal cost-share amount of total program costs, provided the interests in lands contribute to the goals of the Forest Legacy Program and the lands are located within a Forest Legacy Area.

The Landowner Role

Landowner participation in the FLP is voluntary. A landowner joins the program either by conveying interests in lands to achieve the conservation objectives of the FLP or by purchasing or inheriting land that has already been committed to an FLP conservation easement. The landowner becomes a primary practitioner in maintaining the forest land base by implementing management activities guided by a Forest Stewardship Plan to conserve the values for which the land entered the program.

The Forest Legacy Program (FLP) is authorized in the Food, Agriculture, Conservation, and Trade Act of 1990 (Pub. Law No. 101-624) on November 28, 1990. The law identifies Maine, New Hampshire, Vermont, New York, and Washington State as the participating States. Additional programs could be established through assessments of need for such programs.

On April 20, the first FLP project is completed with the fee acquisition on 1,660 acres at Cow Mountain Pond in Vermont. The first State Assessment of Need (AON) is approved for Massachusetts on August 5. The first FLP conservation easement is completed on 1,272 acres at Mooslookmeguntic and Cuspsuptic Lakes in Maine on December 29.


The FLP has protected a total of 9,436 acres of land or interests in land valued at \$5,143,300 with a total FLP payment of \$1,542,000. Eight State AONs are approved in 1994, bringing the total number of active States in the FLP to 11.

In the late 1980s, industrial timber land sales in northern New England caused New Englanders to realize that “paper company” lands, which had traditionally been open for public access and had provided timber products to numerous mills in the region, were in danger of conversion to other uses. This threat led Congress to direct the U.S. Forest Service to study the timberland resources of New York, Vermont, New Hampshire, and Maine, an area referred to as the Northern Forest Lands. The Governors of these four States commissioned a task force to carry out this study. Its purpose was to assess the resources, ownership patterns, and the impacts of conversion of timberlands in this area, then identify strategies to protect its long-term integrity and traditional uses. One of the strategies identified in the study was to acquire lands and conservation easements to permanently protect key parcels from conversion to nonforest uses.


The Forest Legacy Program was created for “the purposes of ascertaining and protecting environmentally important forest areas that are threatened by conversion to nonforest uses and, through the use of conservation easements and other mechanisms, for promoting forest land protection and other conservation opportunities.”

Congress rescinds \$7.8 million of unspent FLP funds as the backlog of unspent funds grew faster than the Forest Service was able to spend those funds.

The State Grant Option is authorized in the 1996 Farm Bill. This amends the FLP to allow States as well as the Federal Government to acquire FLP tracts and conservation easements. The second FLP Implementation Guidelines are issued on August 15, 1996. The FLP sign art is finalized, giving the FLP visual brand recognition. Total FLP accomplishments exceed 50,000 acres when the first FLP project using the State Grant option was completed, a 31,450-acre conservation easement on the Hancock Tract in Vermont.

FLP appropriations for the year reach the lowest level to date at \$2 million.

First efforts to develop a prioritized list are undertaken in three geographical regions of the country for a portion of the appropriated funds.

Congress appropriates \$30 million for Fiscal Year 2000, four times greater than the prior fiscal year appropriation of \$7 million.

Timeline of the Forest Legacy Program: The First 20 Years



Total FLP accomplishments exceed 100,000 acres when a 20,268-acre conservation easement on the Nictaus Lake Tract in Maine is completed. Minnesota sets the stage for presenting multitract projects by receiving funding for the six-tract Rice County Big Woods project.



Total FLP accomplishments exceed 250,000 acres with an 18,430-acre conservation easement on the Bunnell Mountain Tract in New Hampshire. The Maine Nictaus FLP project is awarded the national Taking Wing Award.*

*Taking Wing recognizes significant contributions of Forest Service partners and field units to the conservation of waterfowl, shorebirds, water birds, and other wetland-dependent wildlife.

The National Ranking panel meets in January to identify potential FLP projects and prioritize those projects in a national list. The National FLP database for FLP project submission and completion tracking—the Forest Legacy Information System (FLIS)—is launched. The House Appropriations Committee Surveys and Investigations staff investigates the FLP. The appropriations report on the FLP released in November leads to the development of new FLP implementation guidelines and calls for Quality Assurance Inspections for FLP appraisal service.




The third FLP Implementation Guidelines are issued on June 30, 2003. Total FLP accomplishments exceed 500,000 acres with a 146,290-acre conservation easement on the Connecticut Lake Headwaters Tract in New Hampshire. The West Branch project, the largest FLP project in requested funding to date, is completed using nearly \$19.7 million in FLP funds.



Total FLP accomplishments exceed 1 million acres when a 23,150-acre conservation easement on the Marble Creek Phase II Tract in Idaho is completed.

All 20 Northeastern Area State and Private Forestry States have an approved Assessment of Need (AON) in place when AONs for both Ohio and Missouri are approved in August 2005.

Massachusetts successfully secures FLP funds for the 18-tract Quabbin Corridor Connection project, setting a new upper limit for multitract projects. Another Maine FLP project, The Machias River project, receives national recognition—the Wings Across the Americas Habitat Conservation Award.

Total Northeastern Area State and Private Forestry accomplishments exceed 1 million acres with the completion of two conservation easements on the same day in March on the Katahdin Iron Works Tract in Maine and the Bald Mountain Tract in New Hampshire. Total national FLP accomplishments exceed 1.5 million acres when a 483-acre fee acquisition of the Garmon Branch Tract in Kentucky is completed in July.

All 20 States served by Northeastern Area State and Private Forestry have land protected by the FLP when Missouri completes a fee acquisition on the 154-acre LaBarque Creek Tract.

Massachusetts completes the 1,667-acre, 18-tract Quabbin Corridor Connection project in 3 years, which shows that multitract projects can compete for funding and meet the same time limits as large-acreage, single-tract projects.

Total FLP accomplishments exceed 2 million acres with the 6,966-acre fee acquisition on the Vinton Furnace Experimental Forest Tract in Ohio. The FLP, which began with only five States 20 years ago, has expanded to become a national program that covers all types of forest in the United States. Forty-nine States and 4 U.S. Territories are currently active in the FLP.

The idea of using conservation easements to conserve forest land originally developed in New England. The New England States were the first to embrace the FLP as evidenced by the first FLP accomplishments. Over the ensuing 20 years, most of the country joined the FLP. At the same time, the basis for a strong FLP was established and is chronicled here. The States that have joined the FLP and have successfully protected landscapes by acquiring land or interests in land are leaders in extending their influence of professional forest management to expanses of private forest land. This foundation and influence will keep our important forest land into perpetuity.

Forest Legacy Projects Completed During FY 2010

FY 2010 accomplishments of the Northeastern Area State and Private Forestry Forest Legacy Program, including projects in the States of Maine, Massachusetts, Michigan, New Hampshire, New Jersey, Ohio, Pennsylvania, Rhode Island, Vermont, West Virginia, and Wisconsin, are highlighted on the following pages.

Grafton Notch – Stowe Mountain – Maine

The 3,364-acre Grafton Notch – Stowe Mountain conservation project protects views from the Appalachian Trail, a National Scenic Byway, and Grafton Notch State Park. The project is adjacent to the FY 2007 Grafton FLP fee acquisition that protected 3,688 acres of forest. The Stowe Mountain project closed on December 11, 2009. Maine's Bureau of Parks & Lands purchased the working forest conservation easement valued at \$1,567,800 from the landowner—The Center for Special Needs Trust—with \$1,111,000 from the FLP. Additional funds, including a stewardship endowment, came from the Land for Maine's Future Program and from mitigation accounts created as a result of a wind power generation project.

Southern Monadnock Plateau I – Massachusetts

The Southern Monadnock Plateau I project is the first of three phases that will protect over 5,000 acres of forest in north-central Massachusetts. This phase is a multitract project composed of 12 tracts; 11 have been completed so far. The 11 tracts completed protect 1,132 acres of forest from conversion to nonforest uses through the mix of conservation restrictions and fee purchases. The first two tracts, 68- and 55-acre conservation restrictions, were protected in June 2009; the remaining tracts were completed in July 2009 on 144 acres, October 2009 on 303 acres, January 2010 on 343 acres, and June 2010 on 210 acres. The \$3,512,000 total cost of the first 11 tracts was paid for with \$2,474,000 in FLP funds and \$1,038,000 in cost-share funds that included landowner donations, funds from the State of Massachusetts, and funds from the Town of Westminster. Combined, the properties provide protection of headwater streams of the Millers and Nashua Rivers, and public access to and protection of 3.3 miles of the Midstate Trail, a priority recreation corridor. The remaining tract will close in early FY 2011.

Northern Great Lakes Forest – Michigan

The final phase of a 247,803-acre working forest conservation easement project in Michigan's Upper Peninsula was completed by the Michigan Department of Natural Resources (DNR), with assistance from The Nature Conservancy (TNC), on September 29, 2010. The FLP protected 150,991 of those acres. The DNR worked extensively with TNC and the landowner, Heartwood Forestland Fund IV, to complete this unprecedented accomplishment for Michigan's premiere natural resources. The FLP contributed \$3,979,000 towards the final phase 30,803-acre conservation easement that is valued at \$5,094,000. The Michigan Natural Resources Trust Fund provided the remaining \$1,115,000 as part of the non-Federal cost share for the project; an additional cost share for the project occurred with TNC gifting an adjacent conservation easement covering 53,170 acres with a value in excess of \$8,000,000 to the DNR.

Ossipee Pine Barrens – New Hampshire

The Ossipee Pine Barrens ecosystem is the last of its kind in New Hampshire. It contains exceptional natural resources, including the globally rare pitch pine-scrub oak barrens. Completion of the five-tract, 2,320-acre Ossipee Pine Barrens project permanently protects several of the largest and most important remaining tracts in this forest landscape. New Hampshire acquired a conservation easement on the properties on November 6, 2009, from The Nature Conservancy, which had previously acquired the properties from private landowners. The \$3,667,000 value of the easements was purchased for \$2,351,000 in FLP funds. The cost share for the project was achieved through bargain sales on three of the tracts and a donation of the conservation easements to the State on two of the tracts.


Mission Society – New Jersey

The 1,134-acre Mission Society project, located in the New Jersey Highlands, provides full public access and direct connection to more than 62,000 acres of conservation land. The fee acquisition of this parcel protects potable water resources, supports biodiversity, and allows for extensive regional public recreation. The tract was acquired by the New Jersey Green Acres Program in October 2009 from its landowners, the Paulist Fathers. The value of \$6,235,000 was met using funds from the New Jersey Green Acres Program, of which \$3,747,000 was reimbursed by the FLP on June 30, 2010, after all FLP standards were met. A nearby tract acquired by Green Acres valued at \$1,230,000 will be used as the remaining non-Federal cost share for the FLP funds.



Vinton Furnace Experimental Forest – Ohio

This multipartner effort was completed on August 16, 2010, with the purchase of the 15,494-acre Vinton Furnace Experimental Forest by the State of Ohio. The project protects Ohio’s largest remaining privately owned contiguous forest block, which includes a federally designated experimental forest that is home to over 50 years of ongoing forestry research. The land will be Ohio’s newest State forest and State wildlife area. The 12,089-acre State forest will be called the Vinton Furnace State Experimental Forest and will provide the public with recreational opportunities, promote native wildlife, maintain ongoing forestry research, and support sustained timber production. The 6,966-acre FLP portion of the project was purchased for \$7,697,131 using \$5,136,250 of FLP funding and a cost share of \$2,560,881 from the State of Ohio.

Tree Farm #1 – Pennsylvania

A two-year partnership involving Federal, State, and local governments, private organizations and the citizens of Adams County, Pennsylvania was completed on May 17, 2010. The Pennsylvania Department of Conservation and Natural Resources (DCNR) purchased the 2,500-acre Tree Farm #1 property in Hamiltonban Township from The Conservation Fund; 1,466 acres were FLP acres. The Conservation Fund had previously acquired the property from Glatfelter Pulp Wood Company. The property, now part of the Michaux State Forest, serves as a buffer to the Appalachian Trail corridor and lies within the viewshed of Gettysburg National Military Park. The 1,466-acre FLP portion of the project valued at \$5,070,000 used FLP funding in the amount of \$3,500,000 and was cost shared with \$2,070,000 from the DCNR.

Harrington House Woodlands – Rhode Island

In July 2008, the State of Rhode Island acquired a conservation easement from landowner Ernest Bugnet on 69 acres of his forested land in Exeter, RI, known as the Harrington House Woodlands tract. Ernest and his wife, Marie, purchased the parcel in the early 1960s as a means to support Ernest’s custom wood molding business and to provide themselves with firewood in order to save money heating their home. The conservation easement, valued at \$769,655 along with its acquisition costs, was purchased by the State through a bargain sale for \$600,000, of which \$591,000 was from FLP funds and the remaining \$9,000 from State funds. After all FLP standards were met on December 18, 2009, the FLP reimbursed the State \$591,000.

Chittenden County Uplands – Vermont

The final tract on the multitract Chittenden County Uplands project closed on June 29, 2010, 4 years to the day after the first tract was completed on June 29, 2006. This project is comprised of 11 conservation easements and one fee acquisition that combined protects 5,287 acres of private forest in the most populated county in the State. The project fills in crucial gaps to link existing protected lands in the area—Camel’s Hump State Park to the south, Mount Mansfield State Forest to the east, and the Ethan Allen Firing Range to the north. The fee and conservation easement acquisitions were valued at \$4,486,000 with the FLP providing \$4,409,000. The required non-Federal cost share for the project was made through the fee acquisitions on four tracts of land totaling 783 acres valued at \$1,480,000 and were acquired without the use of any Federal funds.

Potomac River Hills – West Virginia

The Potomac River Hills Forest Legacy project was completed by the West Virginia Division of Forestry on June 30, 2010. A working forest conservation easement was placed on the 2,505-acre property owned by The Conservation Fund in the West Virginia Eastern Panhandle. This land is ready for immediate forest management. The property contains 10 forested stands containing approximately 10 million board feet of sawtimber. The property contains an excellent, well-maintained forest road system, which greatly facilitates implementation of silvicultural practices. The \$4,510,000 appraised value for the acquisition of the conservation easement was paid for with \$2,267,000 in FLP funds. The remaining value was donated by the landowner and serves as the cost share for the project.

South Branch – West Virginia

The State of West Virginia has acquired an FLP conservation easement on a 144-acre forested tract that is adjacent to the State’s first 764-acre FLP property. The so-called Trough 2 tract is located in the Eastern Panhandle of the State in the South Branch of the Potomac River watershed. On June 30, 2010, a conservation easement was purchased by the State of West Virginia from landowners Brent and DiAnna Liller at a bargain sale price of \$141,000. The conservation easement appraised at \$188,000 and will allow the landowners to continue to manage the property for forest products guided by a State Forester-approved Forest Stewardship Plan. After all FLP standards were met on September 23, 2010, the State of West Virginia was reimbursed \$141,000 with FLP funds.

Tomahawk Timberlands – Wisconsin

The third and final phase of the Tomahawk Timberlands Project has been completed with the acquisition of a 1,546-acre fee simple purchase as part of the Willow Flowage Scenic Water Area. This October 9, 2009, purchase from Potlatch Forest Holdings protects over 7 miles of scenic river frontage along the Tomahawk River as well as a significant portion of the river corridor from the Willow Flowage to Lake Nokomis. The \$4,000,000 appraised value of the property was acquired with the help of the U.S. Forest Service FLP providing \$1,972,000 of the acquisition cost and the State of Wisconsin providing \$2,028,000. This phase concludes the Tomahawk Timberlands project. Phases I and II completed in November 2002 by the FLP are conservation easements totaling 35,377 additional acres.




Forest Legacy Program Costs by Federal and Non-Federal Entities**






